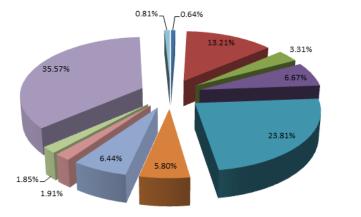
HUNTSVILLE 2017 DRAFT OPERATING & CAPITAL BUDGET

- Operating 3.17% (\$318,389)
- Capital 20.74% (\$539,823)
- Total levy increase 6.79% (\$858,212)
- For every \$100,000 in assessment, tax payers will pay \$362/year; an increase of \$19.
- This represents a 5.48% increase in the residential tax rate from the previous year.
- For a typical home valued at \$246,000 the tax bill for the Town of Huntsville will be \$891/year (compared to \$844 in 2016).

How Your Tax Dollars Are Spent

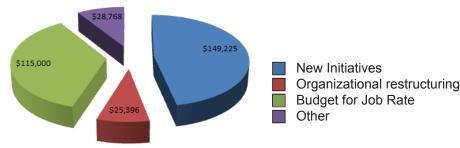

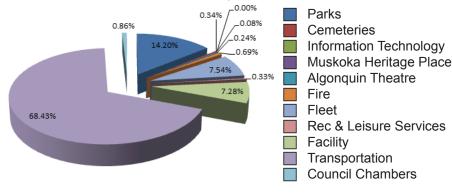
Operating Increase Summary

- Additional \$318,389 in operating funding from the levy
- Represents an additional 3.17% over the prior year operating levy
- Of the overall increase of 6.79%, operating accounts for 2.52%



Capital Increase Summary

- Additional \$539,823 in capital funding from the levy
- Represents an additional 20.74% over the prior year capital levy
- Of the overall increase of 6.79%, capital accounts for 4.27%





Capital Asset Management

- Over the next 10 years, the cost of replacement/rehabilitation of existing assets is estimated at \$52,000,000.
- To be sustainable with the current levels of service, the Town needs to fund capital at \$5,200,000/year.
- The funding levels in the 2015 budget were \$2,470,000, which represents 47.52% of sustainable funding.
- To get to a sustainable level, taxes must be allocated each year to increase this funding.

What You Get for Your Property Taxes

On a typical home valued at \$246,000, here is a breakdown of what you get for your Huntsville tax dollars based on draft 2017 budget:
